

**RESOLUTION DETERMINING SEWER SERVICE CHARGES REMAINING UNPAID**

**Resolution #** 09-21

**WHEREAS**, on December 10, 2007, the City Council of the City of Forada (the "Council") enacted Ordinance No. 63, Ordinance Providing for Wastewater Treatment Service Charges (the "Ordinance"); and

**WHEREAS**, Article IV of the Ordinance provides that all sewer service charges levied pursuant to the Ordinance are a lien on the premises served and that all charges which remain delinquent on October 15 of each year, may be certified to the County Auditor after notice provided to the owner of the premises; and

**WHEREAS**, the City Clerk of the City of Forada has filed with the Council a Certificate Regarding Unpaid Sewer Service Charges, a copy of which is attached hereto as Exhibit "A", certifying the amount of sewer service charges remaining unpaid is as set forth thereon, namely, \$ 5,912.00

**NOW, THEREFORE, BE IT RESOLVED** that the Council hereby finds, determines and declares as follows:

1. **Sewer Service Charges Unpaid.** The sewer service charges remaining unpaid is as set forth in the attached Certificate, there being no information to the contrary.
2. **Certificate to County Auditor.** In accordance with Ordinance No. 63 and M.S.A. 366.012, the Clerk is hereby directed to deliver a copy of this Resolution to the Douglas County Auditor and thereby certify the unpaid charges for payment with the taxes levied against the respective premises.
